Description of fees:	<p>Government Funded Tuition Fee: Student who meets the VTG eligibility requirements and is therefore eligible for a government subsidised training place</p> <p>Government Funded Concession Tuition Fee: To be eligible for the concession rate you must be eligible for a government subsidised training place and at course commencement, you must hold a current and valid: Commonwealth Health Care Card, Pensioner Concession Card or a Veteran’s Gold Card, or Jobseeker Referral Form</p> <p>Non funded course fee (Fee For Service): Fee for service rates apply to those applicants who do not meet the Victorian Training Guarantee eligibility requirements.</p>
Other fees that may be applicable:	For re- issuance of Certificates and Statements of Attainments the student will be charged \$50 per document required. Payment for the re-issuance of such documents is required prior to the re-issuance occurring by the RTO.
Refunds:	<p>Cancellation refers to the withdrawal of enrolment prior to the commencement of the course. Withdrawal refers to termination or change of enrolment after the commencement of the course.
